The prerequisites of a Regional Security Manager

I have been a Regional Security Manager since 1996. Looking back, it has not been a smooth sailing for me. Physical health

Thus, your mental alertness is paramount. You can achieve this by having enough rest as well as do some light exercise everyday

Communication skills

A regional manager is always regarded as a consultant and people are always expecting answers from you. Unfortunately, you do not have answers most of the time. Your communication skills will be your savior. You need to acquire these skills or else you may have a disaster on your hands. Fast thinking, public speaking are some of the required skills.

In addition you will have to do some homework before attending any business meetings. You must list down FAQs and anticipated questions. The most difficult part would be how to answer questions that are confidential in nature and you cannot share it. You need to use your own judgment on what you can and cannot share and how not to reveal any confidential facts without upsetting your audience.

Local practices and traditions

- 8. Learn how to do simple building security designs and audits.
